## COVID-19 Urgent Response Grant Application

COVID-19 Urgent Response Grants range from \$5,000 to \$15,000 to help grassroots and community-led, people of color-led organizations respond quickly to the COVID-19 crisis. Grants can be used to support basic needs such as food, shelter, and economic assistance. Priority will be given to frontline people of color-led organizations with budgets under \$300,000.

This is a one-time funding opportunity.

The deadline to apply is **Friday, May 15, 2020 by 5:00 pm**. We will continue to accept applications after this date until all funds are distributed. Haymarket's Funding Panel and review committee will meet every two weeks starting after May 15, 2020 to review and make decisions. **Applications can be submitted by email to [jaime@haymarket.org](mailto:jaime@haymarket.org).**

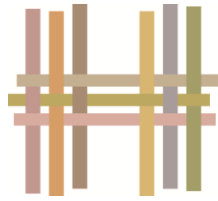
