

#### **Health and Wellness Center**

Year Renovated: 2014

#### **Background**

The Health and Wellness Center is a City-owned gym opened in 2014 and located at the old Everett High School Field House. Everett residents and staff can use the gym. Programs include: strength and cardiovascular training, yoga, children's yoga, Zumba, children's Zumba, spinning, muscle conditioning, adult and children's personal training, classes for teenagers, basketball, soccer, boxing, jujitsu, babysitting, and nutrition.

The address of the Center is 584 Broadway, although the entrance to the Center is on Maple Avenue. Visitors can access the facility by stairs or a ramp. The center is one story and connected to the YMCA. Some emergency exits do have stairs.

There is no dedicated parking lot for the facility, but there is one accessible space that is provided by the YMCA on Maple Street that is included in the assessment.

#### Key Accessibility Issues

#### Ramp

The exterior ramp to the main entrance has damage to the surface and had accumulated water on the day of the survey.

#### Doors

Three doors lacked adequate maneuvering clearance.

#### Service Counter

The main service counter is located higher than 36 inches above the finish floor.

#### **Locker Rooms**

Both men's and women's locker rooms lack compliant benches. The men's locker room also lacks an accessible locker.

#### **Toilet Rooms**

There are multi-user toilet rooms for men and women in the gym and lobby (4 in all). Toilet rooms have minor accessibility issues including lack of audible and visible alarms; exposed plumbing at accessible lavatories; dispensers, hooks and baby changing tables that are beyond the reach range; lack of grab bars in accessible compartments; toilet seats located higher than 19 inches above finished floor in wheelchair accessible compartments; and toilets with the flush control located on the opposite side from the open transfer area. Grab bars in the Lobby toilet room wheelchair accessible compartments have abrasive elements and should be replaced. The urinal in the men's toilet room in the Lobby lacks a urinal that is 17 inches or lower from the finished floor.

#### Additional Accessibility Issues

- Exterior accessible routes have issues with level changes and cross slopes.
- Some curb ramp landings have slopes greater than 1:50 (2.00%) or lack detectable warnings.
- Parking meters on Broadway are not on an accessible route or operable with a closed fist.
- There is noncompliant egress and designation signage throughout the building.
- One egress stair had stored items blocking the exit route. Another lacked compliant continuous handrails.

3 automatic door openers: \$4,590

Signage (egress, designation, directional): \$2,725

Toilet room renovations: \$9,927

#### **Universal Design and Best Practice Recommendations**

- For safety and to prevent falls, consider adding tactile contrast strips and handrails to stairs at the base of the exterior ramp.
- Signage by the old High School may mislead people to think that the Health and Wellness Center is located in the old High School. Consider removing sign or providing a sign directing people to the Maple Ave. entrance. An online Google search also directs people to the old High School. Correct and clarify online information.
- Consider repaving the exterior ramp from the fire stair exit on Linden Street so that the ramp is flush with the sidewalk. At minimum, install a detectable warning to stop people from tripping at the change in level.
